

# **UAE Car Passing Guide**

### Who Needs to Pass the Car Inspection?

- All vehicles older than 3 years: Must undergo annual RTA inspection for registration renewal
- New vehicles (less than 3 years old): Generally exempt until first renewal
- Imported vehicles: Require passing certificate for registration
- Commercial vehicles: May have different inspection schedules

### When to Get Your Car Inspected?

- Registration renewal: Before renewing your vehicle registration
- Ownership transfer: When selling or transferring your car
- RTA notice: If you receive an official inspection notice
- After major repairs/accidents: Especially those affecting safety components
- Custom modifications: After significant vehicle alterations

## **How to Prepare Your Car for Passing?**

- Brakes: Ensure proper function with no leaks or excessive wear
- Lights: Test all headlights, brake lights, indicators, and hazard lights
- Tires: Minimum 1.6mm tread depth, no cuts or bulges
- Emissions: Must meet UAE standards (especially for older vehicles)
- Suspension/steering: No excessive play or leaks
- Vehicle body: No major rust, dents affecting structure
- Chassis number: Clearly visible and matches documents
- Windshield: No cracks obstructing driver's view

## **What Happens During Inspection?**

- Visual inspection: Body condition, lights, mirrors, windshield
- Safety checks: Brakes, suspension, steering functionality
- Emissions test: Tailpipe emissions measurement
- Underbody inspection: Chassis, exhaust system, fuel lines

- VIN verification: Matching chassis number to documents
- OBD scan: For newer vehicles (check engine light etc.)

#### **If Your Car Passes**

- Receive passing certificate: Valid for 30 days typically
- Registration renewal: Proceed with renewal process
- Ownership transfer: Can complete sale/transfer process
- W2D listing advantage: Upload certificate when selling to build buyer trust
- Digital records: Some emirates link directly to registration system

#### If Your Car Fails

- Receive defect report: Detailed list of non-compliant items
- Repair requirements: Must fix at approved garages
- Re-inspection: Return to same center within specified period
- Additional costs: May incur new inspection fees
- Time limits: Typically 30 days to rectify (varies by emirate)
- Multiple failures: May require comprehensive re-check

## **Tips for a Successful Passing**

- Regular maintenance: Follow manufacturer's service schedule
- Pre-inspection check: Visit mechanic 2 weeks before test
- Common failure points: Worn tires, non-functional lights, excessive smoke, warning lights
- Documentation: Bring all required vehicle papers
- Clean vehicle: Especially chassis number area
- Timing: Avoid last-minute inspections before registration expiry
